PUBLIC LIABILITY INSURANCE: Each exhibitor must have Public Liability Insurance Cover to the value of \$10 Million and evidence of such cover must be provided with your application. Cover can be arranged through the AH& P Association for a cost of \$25.00.

IMPORTANT NOTICE TO ALL STALL / TRADE SPACE HOLDERS ELECTRICAL EQUIPMENT AND POWER LEADS

All power cords must be mounted overhead and comply with conditions set down by Country Energy.

Exhibitors intending to bring electrical equipment to the showground will be required to ensure that such equipment is fitted with earth leakage circuit breakers and that all electrical leads, tools and appliances have been inspected and tagged by a licensed electrical contractor.

This is essential for the safety of yourselves, your fellow exhibitors and the general public and is a requirement of the **Occupational Health and Safety Act of 1983**. This Act imposes very severe penalties in the event of non-compliance with the provisions.

All exhibitors who do not comply will not be allowed to exhibit at the showground.

Please check all your electrical equipment and leads before you come to the showground to avoid the occurrence of any difficulty or embarrassment.
